

The fall meeting of the Clemons Pond Association was held on Sept. 2, 1984 at Flo Whiting's camp. Victor said he will be making a contribution to the Hiram Historical Society so that they will donate paint to do the fence around the cemetery. We will be doing the actual painting.

It was discussed to raise the dues from \$5.00 to \$10.00 a year. Victor Zelman moved and Charles Saurman seconded the motion to raise the dues. It was voted to do so by a 2/3 vote of members.

A discussion was held about what constitutes a family if more than one family owns the same property. It was decided that each family is entitled to two votes according to our by-laws.

Ralph Morse reported on the nomination of new officers. Pres.-Louise Ngvak, Vice Pres.-Charles Saurman, Secretary-Mary Penney, Treasurer-Jeannette Ward.

Libby Morse moved that the secretary cast one ballot for the new officers. The motion was passed. Flo Whiting suggested we thank the outgoing officers for a job well done. They were given a hearty applause.

Flo moved to adjourn and Norman seconded. The meeting adjourned at 11:30 a.m.
